## Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.freestatebusinesscenter.com](http://www.freestatebusinesscenter.com) and governs data collection and usage. ## Collection of your Personal Information

In order to better provide you with products and services offered, Free State Business Center may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Free State Business Center may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Free State Business Center collects and uses your personal information to operate and deliver the services you have requested.

Free State Business Center also use your personally identifiable information to inform you of other products or services available from Free State Business Center and its affiliates.

## Sharing Information with Third Parties

Free State Business Center does not sell, rent, or lease its customer lists to third parties.

- SSL Protocol

- Comply with the California Electronic Communications Privacy Act;
